

BiliBili TV Monetization Requirements

Bangladesh & India — 2026 Guide

Important note

BiliBili TV does not appear to publish one universal, current public rulebook stating a fixed follower count and watch-hour threshold for every international creator. Eligibility can depend on the creator account, available monetization program, content compliance, and regional availability. Therefore, this guide avoids presenting unverified numbers as official requirements.

1. Basic creator requirements

Requirement	What to check
Creator account	Use BiliBili TV's Creator Center and maintain an account in good standing.
Original / authorized content	Publish content you created yourself or have the necessary rights to use.
Policy compliance	Follow BiliBili's content, community, copyright, and creator rules.
Account eligibility	Check the Creator Center for monetization or revenue features available to your account.
Payment eligibility	If a revenue program is offered, complete any required payment, tax, or identity verification.

2. Bangladesh and India

Creators in Bangladesh and India can use BiliBili TV and publish videos. However, publishing access should not be confused with guaranteed access to every monetization or withdrawal feature. I could not verify an official BiliBili TV source that guarantees a single monetization program and payout method for all creators in either country. The safest approach is to verify the monetization options shown inside your own Creator Center before planning income around them.

3. Is there a fixed follower/view requirement?

No universal official threshold could be verified from current public BiliBili TV documentation. Avoid relying on claims such as '1,000 followers + 4,000 watch hours' unless BiliBili itself shows those requirements for your specific program/account.

4. Content and copyright checklist

- Prefer original videos and commentary created by you.
- Use music, footage, images, and clips only when you have permission or an applicable right to use them.
- Avoid uploading copyrighted movies, TV episodes, anime, or other material without authorization.
- Keep titles, thumbnails, descriptions, and metadata accurate and compliant.
- Maintain a good account standing and respond appropriately to copyright or policy notices.

5. How to verify monetization on your account

1. Open BiliBili TV Creator Center.
2. Review the monetization/revenue-related features shown for your account.
3. Read the specific eligibility rules displayed for the program before applying.
4. Check whether your country/region and payment method are supported.
5. Complete any required verification and payment information through official BiliBili interfaces.
6. Only then treat the account as monetization-ready.

6. Payouts

A single guaranteed payout method for every international BiliBili TV creator could not be verified from current public documentation. Payment options may depend on the particular creator program and region. Do not assume PayPal, Payoneer, or direct bank transfer is available until the payout section of your own eligible creator account confirms it.

7. Practical recommendation

For a Bangladesh- or India-based creator, the best first step is to build an account with consistent original content, monitor Creator Center eligibility, and verify the exact revenue and withdrawal options offered to your account. This is more reliable than using old third-party monetization figures because BiliBili's programs and regional availability can change.
